

MOCUTE 隐私权政策

MOCUTE 尊重并保护所有使用服务用户的个人隐私权。为了给您提供更准确、更有个性化的服务，MOCUTE 会按照本隐私权政策的规定使用和披露您的个人信息。但 MOCUTE 将以高度的勤勉、审慎义务对待这些信息。除本隐私权政策另有规定外，在未征得您事先许可的情况下，MOCUTE 不会将这些信息对外披露或向第三方提供。MOCUTE 会不时更新本隐私权政策。您在同意 MOCUTE 服务使用协议之时，即视为您已经同意本隐私权政策全部内容。本隐私权政策属于 MOCUTE 服务使用协议不可分割的一部分。

1. 适用范围

- a) 在您注册 MOCUTE 帐号时，您根据 MOCUTE 要求提供的个人注册信息；
- b) 在您使用 MOCUTE 网络服务，或访问 MOCUTE 平台网页时，MOCUTE 自动接收并记录的您的浏览器和计算机上的信息，包括但不限于您的 IP 地址、浏览器的类型、使用的语言、访问日期和时间、软硬件特征信息及您需求的网页记录等数据；
- c) MOCUTE 通过合法途径从商业伙伴处取得的用户个人数据。

您了解并同意，以下信息不适用本隐私权政策：

- a) 您在使用 MOCUTE 平台提供的搜索服务时输入的关键字信息；
- b) MOCUTE 收集到的您在 MOCUTE 发布的有关信息数据，包括但不限于参与活动、成交信息及评价详情；
- c) 违反法律规定或违反 MOCUTE 规则行为及 MOCUTE 已对您采取的措施。

2. 信息使用

- a) MOCUTE 不会向任何无关第三方提供、出售、出租、分享或交易您的个人信息，除非事先得到您的许可，或该第三方和 MOCUTE（含 MOCUTE 关联公司）单独或共同为您提供服务，且在该服务结束后，其将被禁止访问包括其以前能够访问的所有这些资料。
- b) MOCUTE 亦不允许任何第三方以任何手段收集、编辑、出售或者无偿传播您的个人信息。任何 MOCUTE 平台用户如从事上述活动，一经发现，MOCUTE 有权立即终止与该用户的服务协议。
- c) 为服务用户的目的，MOCUTE 可能通过使用您的个人信息，向您提供您感兴趣的信息，包括但不限于向您发出产品和服务信息，或者与 MOCUTE 合作伙伴共享信息以便他们向您发送有关其产品和服务的信息（后者需要您的事先同意）。

3. 信息披露 在如下情况下，MOCUTE 将依据您的个人意愿或法律的规定全部或部分的披露您的个人信息：

a) 经您事先同意，向第三方披露；

b) 为提供您所要求的产品和服务，而必须和第三方分享您的个人信息；

c) 根据法律的有关规定，或者行政或司法机构的要求，向第三方或者行政、司法机构披露；

d) 如您出现违反中国有关法律、法规或者 MOCUTE 服务协议或相关规则的情况，需要向第三 方披露；

e) 如您是适格的知识产权投诉人并已提起投诉，应被投诉人要求，向被投诉人披露，以便双方 处理可能的权利纠纷；

f) 在 MOCUTE 平台上创建的某一交易中，如交易任何一方履行或部分履行了交易义务并提出 信息披露请求的，MOCUTE 有权决定向该用户提供其交易对方的联络方式等必要信息，以促 成交易的完成或纠纷的解决。

g) 其它 MOCUTE 根据法律、法规或者网站政策认为合适的披露。

4. 信息存储和交换 MOCUTE 收集的有关您的信息和资料将保存在 MOCUTE 及（或）其关联公司的服务器上， 这些信息和资料可能传送至您所在国家、地区或 MOCUTE 收集信息和资料所在地的境外并在 境外被访问、存储和展示。

5. Cookie 的使用

a) 在您未拒绝接受 cookies 的情况下，MOCUTE 会在您的计算机上设定或取用 cookies，以便您能登录或使用依赖于 cookies 的 MOCUTE 平台服务或功能。MOCUTE 使用 cookies 可为您提供更加周到的个性化服务，包括推广服务。

b) 您有权选择接受或拒绝接受 cookies。您可以通过修改浏览器设置的方式拒绝接受 cookies。但如果您选择拒绝接受 cookies，则您可能 无法登录或使用依赖于 cookies 的 MOCUTE 网络服务或功能。

c) 通过 MOCUTE 所设 cookies 所取得的有关信息，将适用本政策。

6. 信息安全

a) MOCUTE 帐号均有安全保护功能，请妥善保管您的用户名及密码信息。MOCUTE 将通 过对用户密码进行加密等安全措施确保您的信息不丢失，不被滥用和变造。尽管有前述安全措施，但同时也请您注意在信息网络上不存在“完善的安全措施”。

b) 在使用 MOCUTE 网络服务进行网上交易时，您不可避免的要向交易对方或潜在的交易对方 披露自己的个人信息，如联络方式或者邮政地址。请您妥善保护自己的个人信息，仅在必要的情 形下向他人提供。如您发现自己的个人信息泄密，尤其是 MOCUTE 用户名及密码发生泄露， 请您立即联络 MOCUTE 客服，以便 MOCUTE 采取相应措施。

MOCUTE Privacy Policy

MOCUTE respects and protects the privacy of all users of the service. In order to provide you with more accurate and personalized services, MOCUTE will use and disclose your personal information in accordance with the provisions of this privacy policy. But MOCUTE will treat this information with a high degree of diligence and prudence. Except as otherwise provided in this privacy policy, MOCUTE will not disclose or provide such information to third parties without your prior permission. MOCUTE will update this privacy policy from time to time. When you agree to the MOCUTE Service Usage Agreement, you are deemed to have agreed to the full content of this Privacy Policy. This privacy policy is an integral part of the MOCUTE service usage protocol.

1. Scope of application

(a) When you register your MOCUTE account, you provide personal registration information according to the requirements of MOCUTE;

(b) When you use the MOCUTE network service or visit the MOCUTE platform web page, MOCUTE automatically receives and records the information on your browser and computer, including but not limited to your IP address, the type of browser, the language used, the date and time of access, software and hardware features, and the web page records you need.

(c) User personal data obtained by MOCUTE from business partners through legal channels. You understand and agree that the following information does not apply to this privacy policy:

(a) The keyword information you enter when using the search service provided by the MOCUTE platform;

(b) MOCUTE collects relevant information and data that you have published in MOCUTE, including but not limited to participatory activities, transaction information and evaluation details;

(c) Violation of legal provisions or MOCUTE rules and the measures that MOCUTE has taken against you.

2. Information Use

(a) MOCUTE will not provide, sell, rent, share or trade your personal information to any unrelated third party unless you have prior permission, or the third party and MOCUTE (including MOCUTE affiliates) provide services to you individually or jointly, and after the end of the service, they will be prohibited from accessing all such information, including all that they have previously been able to access.

(b) MOCUTE also does not allow any third party to collect, edit, sell or disseminate your personal information free of charge. If any MOCUTE platform user engages in the above activities, once found, MOCUTE has the right to terminate the service agreement with that user immediately.

(c) For the purpose of serving users, MOCUTE may use your personal information to provide you with information of interest, including, but not limited to, products and services, or to share information with MOCUTE partners so that they can send you information about their products and services (the latter requires your prior consent).

3. Information disclosure: MOCUTE will disclose all or part of your personal information in accordance with your personal wishes or legal provisions in the following circumstances:

(a) Disclosure to a third party with your prior consent;

(b) To provide the products and services you require, you must share your personal information with third parties.

(c) Disclosure to third parties or administrative or judicial bodies in accordance with the relevant provisions of the law or the requirements of administrative or judicial bodies;
(d) If you violate relevant Chinese laws, regulations or MOCUTE service agreement or relevant rules, you need to disclose them to third parties.

(e) If you are a qualified intellectual property complaint and have lodged a complaint, you should disclose it to the respondent at the request of the respondent so that both parties can handle possible rights disputes;

(f) In a transaction created on the MOCUTE platform, MOCUTE has the right to decide to provide the user with necessary information such as the contact mode of the counterparty of the transaction, if either party has fulfilled or partially fulfilled the transaction obligation and made a request for information disclosure, so as to facilitate the completion of the transaction or the settlement of disputes.

(g) Other MOCUTE disclosures deemed appropriate in accordance with laws, regulations or website policies.

4. Information Storage and Exchange MOCUTE collects information and information about you which will be stored on the servers of MOCUTE and/or its affiliated companies. This information and information may be transmitted to your country, region or outside the territory where MOCUTE collects information and information and is accessed, stored and displayed abroad.

5. Use of Cookies

(a) If you do not reject cookies, MOCUTE will set or fetch cookies on your computer so that you can log in or use cookies-dependent MOCUTE platform services or functions. MOCUTE uses cookies to provide you with more thoughtful personalized services, including promotional services.

(b) You have the right to accept or reject cookies. You can reject cookies by modifying browser settings. But if you choose to reject cookies, you may not be able to log in or use cookies-dependent MOCUTE network services or functions.

(c) The information obtained through cookies set up by MOCUTE will be applicable to this policy.

6. Information Security

(a) MOCUTE account has security protection function. Please keep your username and password information properly. MOCUTE will ensure that your information is not lost, abused and altered by encrypting user passwords and other security measures. Despite the aforementioned security measures, please also note that there is no "perfect security measures" on the information network.

(b) When using MOCUTE network services for online transactions, it is inevitable for you to disclose your personal information, such as contact information or postal address, to the counterparty or potential counterparty. Please protect your personal information properly and provide it to others only when necessary. If you find that your personal information is leaked, especially MOCUTE username and password, please contact MOCUTE customer service immediately so that MOCUTE can take appropriate measures.
